Only those contractors that are pre-qualified with the Cobb County-Marietta Water Authority to construct ductile iron water mains of 36-inch and larger diameter (Categories 2, 3, and 4) at the time of the first publication of this notice will be allowed to bid this project.

The approximate extent and character of the Work is generally described as follows:

Replacement of three existing 6-inch and/or 12-inch saddle blow-offs on 48-inch water main with 48-inch x 12-inch or 6-inch Tees and 12-inch or 6-inch blow-offs; replacement of one 6-inch saddle blow-off on a 36-inch water main with 36-inch x 6-inch Tee and 6-inch blow-off; abandonment of 14-inch valve, removal of two 48-inch and one 20-inch valves, installation of new 48-inch gate valve, and making new connection to an existing 6-inch DIP water main off the existing 36-inch DIP water main.
