This Revised Unit Price Form **MUST** be used by all Bidders for this project. The UCBF on bidexpress.com has been updated to reflect the changes on the attached UCBF. **Failure to submit on the revised Unit Price Form shall be cause for the bid to be rejected.**

COMMENTS & QUESTIONS:

1. We'd like to request the flow data for the 18" on Clay Cut and the 18" behind Carol Marie, as well as the flow data on the 30" to adequately size the sewer bypass.

Estimated flows for the requested pipe segments are below.

3. In the addendum the answer to question #26 appears to be contradictory. #26 states the QPL applies to every project and to refer to QPL 1 of the Contract Documents. However the products in question in #26 are not listed in QPL 1. Can there be a clarification on this issue?


Please refer to page QPL 1 of the contract document that states "Be advised, the QPL is for informational purposed and is not intended to be all inclusive. If the products meets the specifications outlined in the Contract Documents but is not on the QPL, it may be used as long as the necessary certification documents are submitted according to the specifications, reviewed, and deemed as an approved equal by the Owner and Engineer".
