For those items for which more than one acceptable manufacturer is listed, the Bidder must bid on the basis of the Base Bid AND enter amounts to add or subtract for the alternate manufacturers.

For comparable named equipment the furnished items shall fulfill the function and performance of the item specified and shall be of equal quality; any modifications required by the furnished equipment to the structure, process, associated equipment, or piping shall be a consideration in the Bid price and the completed installation of the item by the Contractor shall incur no additional cost to the Owner.

Bid Holding Time: The undersigned hereby agrees that this bid may not be revoked or withdrawn after the time set for the opening of bids but shall remain open for acceptance for a period of sixty (60) days following such time.

Contract Acceptance: In case the undersigned be notified in writing by mail, or by delivery of the acceptance of this bid within sixty (60) days after the time set for the opening of bids, he agrees to execute and deliver to Owner within ten (10) days from the date of the Notice, a contract (AIA Standard Form of Agreement Between Contractor and Owner When A Stipulated Sum Forms the Basis of Payment, AIA for A101) as modified by the supplement thereto prepared by Owner for the Work for the above stated amount and at the same time to furnish and deliver to the Owner a Performance Bond and a Labor and Material

Payment Bond in the form issued by the American Institute of Architects (AIA Form A 312), or such other form which is acceptable to Owner, each in an amount equal to one hundred percent (100%) of the contract sum.

Completion Time: The undersigned agrees to commence actual physical work on the site with an adequate force and equipment within ten (10) days from the date of the Notice to Proceed. He also agrees to provide substantial completion of the Project not later than 630 days from the date of Notice to Proceed. It is important to the Owner that he be able to occupy the new facility as soon as possible. The project must be complete and ready for occupancy 30 days following the substantial completion deadline.

Bid Security: Enclosed is a Bid Bond in the amount of:

The undersigned agrees that, if he fails to execute the contract to Owner within the ten (10) day period from the date of the Notice, or if he fails to deliver to Owner both a Performance and a Payment Bond acceptable to Owner, the obligation of the Bid Bond will remain in full force and effect and the moneys payable thereon shall be paid into the funds of the Owner as liquidated damages for such failure.
