In case of discrepancies between written amounts and figures, written amounts shall take precedence over figures and the sum of all Bid extensions (of unit prices) plus lump sum items shall take precedence over BID TOTAL.

The bid prices shall include all costs of completion of the work except as otherwise specified in the Contract Documents.
