

INVITATION FOR BIDS Date Issued: 2021-06-03

GW CIP No. 187 24-inch Augusta Road Water Main

Greenville Water is inviting sealed bids from its qualified bidders for the proposed construction of approximately 8260 linear feet of 24 inch DIP water main and appurtenances along Augusta Road (US Hwy 25) to interconnect between existing portions of its water transmission systems from Antioch Church Road to Bracken Road/Donaldson Road. This project will also include approximately 4030 linear feet of 12" DIP water main and appurtenances along Perimeter Road near the Donaldson Center, 120 linear feet of 8 inch DIP on Milledge Road and 175 linear feet of 6 inch DIP on Mackenzie Drive in Greenville County. The construction documents for bidding have been prepared for Greenville Water by Davis & Floyd, Inc. Bids will be opened and read aloud at the time and place below.

A Mandatory Pre-Bid Meeting will be held on <u>Thursday, June 10, 2021 at 2:00 p.m.</u> (local time) at the Greenville Water Operations Center Conference Room, 517 W. Washington Street, Greenville, SC 29601 at 2:00 p.m.

Due to the degree of coordination required on the project, it shall be mandatory that a representative of the Bidder be in attendance at the Pre-Bid Meeting.

<u>FEES FOR DOCUMENTS</u>: There are no fees for bid documents obtained electronically by emailing <u>documents-FLO@davisfloyd.com</u>. A non-refundable fee of \$250.00 will be required for each hard copy set of Drawings and other Bid Documents requested.

Questions may be addressed to the Project Manager listed below until Close of Business (5:00 p.m. (local time)) on June 10, 2021. All questions must be in writing and clearly stated. No verbal responses will be provided. Questions should be e-mailed.

Bids will be binding for a period of ninety (90) calendar days from the date bids are opened.

Bids are to be accompanied by a bid bond or certified check of not less than five percent (5%) of the base bid.

The successful bidder will be required to furnish Performance Bond and Labor and Materials Bond in the amount of one hundred percent (100%) of the Contract Amount.

Bids are to be submitted on the Bid Form provided, enclosed in a sealed opaque envelope bearing the name and address of the bidder, contractor's license number, bidder's license number, identification of contract being bid and name of project. All bids must comply with the laws of the State of South Carolina.
