## Part III – Responses to Questions:

1. Question: Reference specifications Section 01026, page 2 of 14, par. 'C', Item No. 4 and 5, sub-par. 1, Method of Measurement, sub-par. a, this paragraph states, "The quantity to be paid shall be the number of linear feet of pipe furnished and installed by directional drill as measured on the Drawings." The distance on the drawings from one end of a drill to the other end will be less than the actual amount of pipe installed by directional drill, to pay the distance as measured on the Drawings is not fair and the Contractor should be compensated for the actual footage of pipe installed by directional drill. Reference to the part of this paragraph that reads "as measured on the Drawings" needs to be removed.

Answer: See Addendum No. 3 and 202050 Bid Form\_Addendum No. 2.

2. Question: Reference Bid Form, page 1 of 2, Items No. 4 and 5, the quantities for these items are inflated and do not match the lengths shown on the Drawings for the total lengths of these drills. If the Contractor is only going to be paid the length of the drill "as measured on the Drawings", then the bid quantities need to reflect the lengths shown on the drawings and let the Contractor build into their price the additional length of pipe needed to directional drill. Please revise bid quantities for these two (2) bid items.

**3. Question**: Reference specifications Section 01550, MAINTENANCE OF TRAFFIC, page 1 of 2, par. 1.01, Description of Requirements, sub-par. A, second sentence, "preparing a signed and sealed approved traffic control plans", there is not enough time between now and the bid date to find an engineer that will commit the time to evaluate preparing a traffic control plan and putting a cost together for it, please delete this language. Besides, F.D.O.T. Indexes will suffice for traffic maintenance and those are readily available. Please delete any reference to "signed and sealed" in these specifications.

Answer: Section 01550 – Maintenance of Traffic remains as stated.

**4. Question**: Will a 6.5% Sarasota County Utility Permit fee have to be paid to the County for a Utility Permit?

Answer: No.

**5. Question**: Reference Bid Form, page 2 of 2, the \$5,000.00 Permit Allowance, what permits will be covered by this allowance? Please clarify.

**Answer:** All permits with the exception of the Utility Regulatory Permit have been obtained. The \$5,000 permit allowance is for anything outside of these permits that may be unforeseen at this time.

**6. Question**: Will a 6.5% Sarasota County Utility Permit fee have to be paid to the County for a Utility permit?

Answer: No.

**7. Question**: Reference specifications Section 02300, page 11 of 19, par. 3.02 PRE-CONSTRUCTION AND POST-CONSTRUCTION SURVEYS, are these requirements necessary since the specifications already require pre and post video recording per specifications Section 01390? Please advise.

**Answer:** See Section 02300 – Horizontal Direction Drilling and Addendum No. 3, revised Section 01026 – Measurement and Payment R3.

**8. Question**: Please provide plan sheets with plotted locations for soil borings number B-09 and B-10.

Answer: See Addendum No. 2 and revised Identification Sheet Number 62.

**9. Question:** Reference plan sheet 77, Inspection Manhole Detail, the butterfly valve, drawn in the detail, is noted as having restrained joints, is this butterfly valve to have mechanical joint ends and be restrained with Meg-a-Lug restrainers or is the valve to have flanged ends and bolted to flanged end ductile iron pipe? Please clarify.
