## **Technical Specifications**

PART A BIDDING AND CONTRACT REQUIREMENTS

- 1. 00312-1 Contract Documents Section 00312, Bid Schedule, Bid Tabulation Form REPLACE the form with the one provided in Attachment 1 of this Addendum.
- 2. 01025-10 Project Manual Section 01025, Measurement and Payment, Paragraph 1.25, Install Vortex Drop Structure, A. Measurement; ADD the following sentence to the end of the paragraph:

"The Vortex Drop Structure will be purchased through the allowance provided. The Contractor is responsible for ordering the equipment through the allowance. This installation bid item includes unloading the equipment, and providing all additional materials, equipment, and labor to install it in accordance with the Drawings and the manufacturer's recommendations."

3. 01025-14 Project Manual 01025, Measurement and Payment, Paragraph 1.36, Cash Allowances, ADD the following paragraph:

## "E. VORTEX DROP STRUCTURE PURCHASE ALLOWANCE

The Owner has received a firm quote for the vortex drop structure, to include freight and taxes. This allowance shall be used for the purchase of that equipment. All other equipment, materials, and labor required for the installation of the vortex drop structure shall be included in other bid items."

4. 01025-7 Project Manual Section 01025, Measurement and Payment, Paragraph 1.18, Sewer Cleaning; REPLACE Paragraphs A and B with the following:

"No separate payment shall be made for sewer cleaning. The contractor shall be responsible for cleaning the sewer lines prior to pre-rehabilitation inspection and lining in accordance with Section 02760."

5. 01025-7 Project Manual Section 01025, Measurement and Payment, Paragraph 1.19, CCTV

Inspection; REPLACE Paragraphs A and B with the following:

"No separate payment shall be made for sewer inspection. The contractor shall be responsible for conducting pre- rehabilitation inspection necessary to verify services and identify defects that may impact the work. Post-rehabilitation television inspection shall be included in the rehabilitation item to which it pertains. CCTV inspection shall be done in accordance with Section 02651."
