





2: Hangar Road/Piney Top Dr/Yorkmont Road



INSTRUCTIONS TO BIDDERS

- Contract Time: 420 Calendar Days
- Minimum Insurance Requirements:
 - Commercial General Liability Insurance and Vehicle Liability Insurance: \$5 Million Each
- Liquidated Damages:
- I. For the first 60 days the contract time is exceeded, fifteen thousand dollars (\$15,000.00) per calendar day will be assessed against the Contractor for each calendar day or portion thereof that the total contract time is exceeded.
- II. Thereafter, twenty five thousand dollars (\$25,000) per calendar day for each calendar day or portion thereof.

Liquidated damages for failure to reopen taxiways and runways by scheduled reopening time will be as follows:

- I. One hundred fifty dollars (\$150.00) per minute for the first 15 minutes.
- II. Two hundred fifty dollars (\$250.00) per minute for each minute thereafter.

Liquidated damages for SIDA fence breaches or damage to the SIDA fence will be as follows:

- I. Twenty-five thousand dollars (\$25,000.00) per occurrence will be assessed against the Contractor for lack of security oversight (inspector) during SIDA breaches.
- II.
 Two thousand dollars (\$2,000.00) per occurrence will be assessed against the Contractor

 for damage to the SIDA fence.




PROJECT SCOPE


- Major Items of Work Include:
 - 1.85M Cubic Yards Embankment
 - 3,330 Linear Feet of Dual Barrel, 10'x10' Concrete Box Culvert
 - 3,200 Linear Feet of New 30" DIP Gravity Sanitary Sewer Pipe
 - Construction of Regional Detention Basin Along Coffey Creek
 - Construction of New Stormwater Pipe Network and Drop Inlets for Future Deicing Pad
 - Specifications Include FAA, Charlotte Water, NCDOT

- Sheets Labeled and Divided in to 3 Project Area Categories: 1-Airfield, 2-Detention Basin, 3-Borrow Sites
- Mobilization Pay Item 10% Project Cap
- C-105 Includes Flaggers, Gate Guards
- Crossing of Taxiway Sierra for Borrow Site 12 Borrow Operations
 - Requires Construction Traffic Flaggers
 - Requires Construction of New Stone Haul Road & SIDA Gate
 - Requires Taxiway Shoulder Reconstruction
- Three Major Construction Phases
 - SIDA Fence Will Be Relocated
 - Majority of Project Outside SIDA


- New Stormwater Drainage Construction
 - Drop Inlets Located in Future Deicing Pad Constructed Low
 - Package 2 Contractor Will Construct Riser/Chimney & Place Grate



- Removal of Taxiway U
 - Concrete Removal, Including Crushing Operation
 - Reuse Crushing Operation Biproducts in Construction of New Haul Road For Taxiway Sierra
- Rock Removal & Excavation Limits Refer to Details & P-152



- Culvert & Sanitary Sewer Construction
 - Typical Pay Limits As Shown Below; Foundations Per M-160
 - Excavation for Culvert/Sewer in Existing Ground Incidental to Culvert/Sewer Pay Item



- Culvert Construction Includes Incidental 12" Stone and Geotextile Bedding
- Culvert Design is Cast-In-Place
 - Precast Construction Will Be Considered Per 1-SC0.01 Requirements
- On-Road Hauling Anticipated Around the Clock
 - West Boulevard Rush Hour Traffic Awareness
- Alternative Hauling Methods Will Be Considered (Off-Road, Belts)
 - Alternative Methods Subject to Airfield Restrictions
- Demolition Items and Unsuitable Soils Must Be Taken Off Airport
 Property

- Regional Detention Basin Constructed South of Project (South of Byrum Drive)
 - Excess Material, Including Rock Must Be Utilized in Embankment
 - New Sewer Alignment
 - Working Around Coffey Creek
- Certain Major Work Elements Will Not Be Permitted to Commence for Up To 60 Calendar Days (Note 4, Areas and Operations Impacted by Construction, Sheet GC0.02)
- Phase 2 Nightwork Restrictions (2300-0530)

 Contractor Employee Badging Needed for Flaggers/Gate Guards, SIDA Fence Relocations and Drainage/Grading Work Along Taxiways A & E TOFA Inside SIDA
